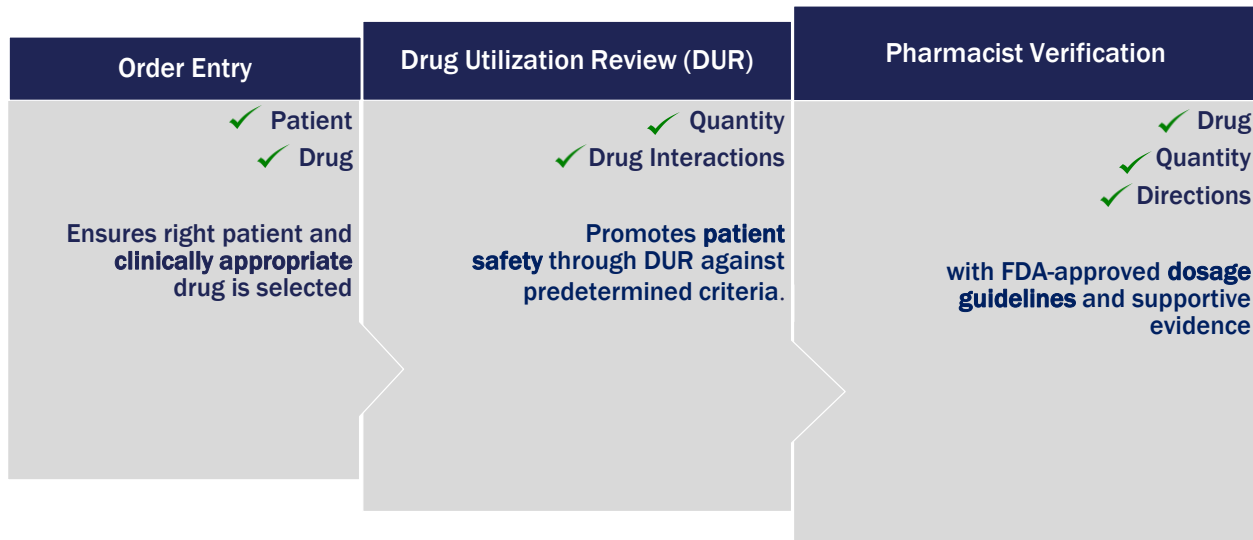

What is Prescription Processing?

Primary process for Prescription Order Entry and Pharmacist Verification, by ensuring:

- The prescribed drug is entered with correct dosage
- No conflicts with other medications – i.e. drug utilization



Prescription Processing – Improvements

- Well defined, organized and configurable prescription processing flow
- Single point of visibility and reporting
- System driven work assignment based on user's knowledge and skillset
- Flexible business rules
- Monitoring, SLA and prioritization for prescriptions/tasks
- Validation and alerting based on configurable business rules
- Maintainability and flexibility
